A LITTLE HISTORY ...

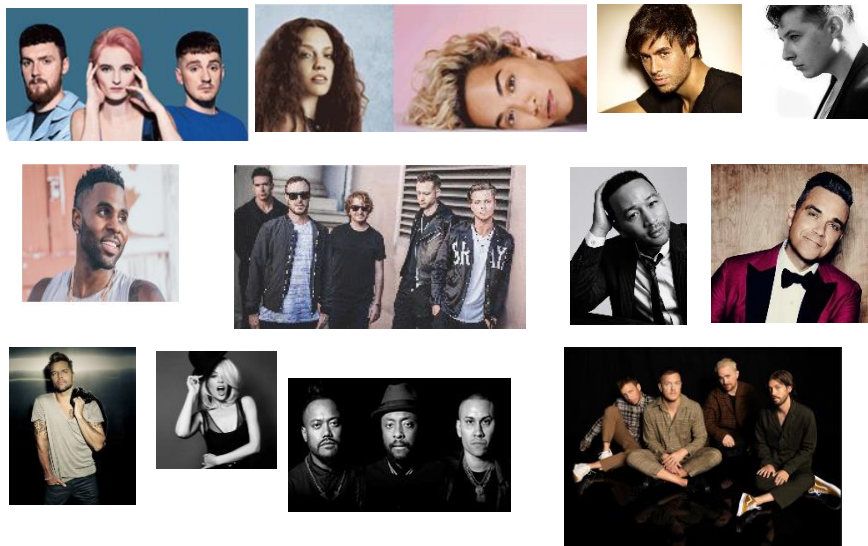
Hotel Cala Di Volpe

The proposed Scope of work ...

SCOPE OF WORK GUIDLINES

Sardegna Resorts intends to assign to an event management company a **mandate to organise the Gala Night (“Gala”)** for the season 2025

The business idea is to leverage on the past experience to propose again to the market one of the most important and glamour events that characterized Costa Smeralda in the recent years

The Gala project will take pace during the 2025 summer season, and date will be approximately around end of July for the first Gala and beginning/mid of August for the second Gala

The business model is structured offering to international and important clients the opportunity to experience a tailored and exclusive event that will be located in the heart of one of the most glamour's summer destination of the world

The Gala nights will be realized in line with the repositioning of Costa Smeralda undertaken by Sardegna Resorts

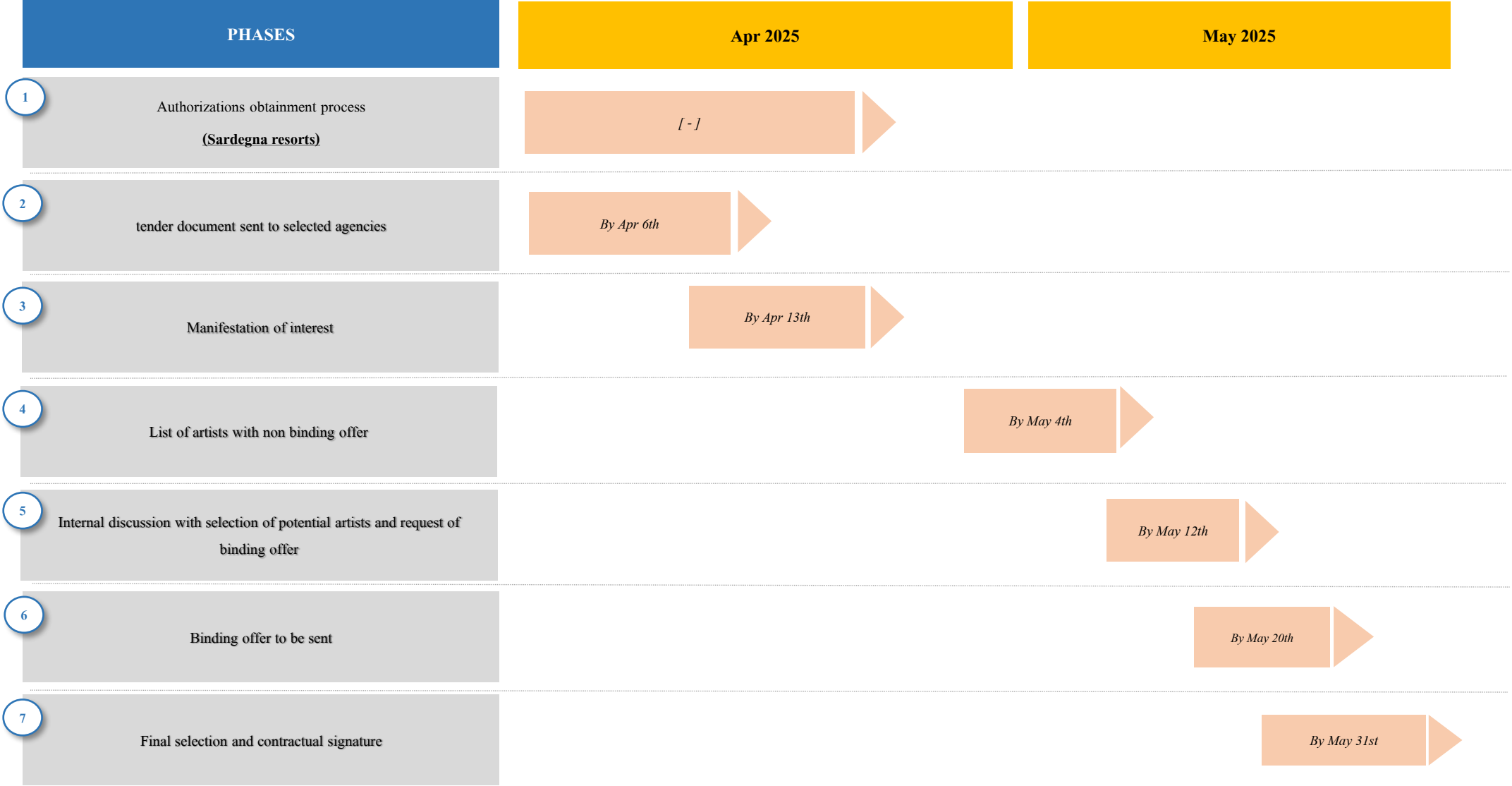
The cost of the realization of the Gala (*Turn key support*) will be bear by Sardegna Resorts S.r.l.

The advisor should offer to Sardegna Resorts a turn key support to complete the project and to identify and organize the gala nights

It is required to have two set of proposed artists with a total contractual value range of a) max Euros 750.000,00 b) max Euros 1.000.000,00 and c) max Euros 1.500.000,00

Contractual value shall include artist cachet/fee, flights and transportation cost to/from the venue, fee related to artist crew/band, accommodation cost and extras for artist and crew/band, meals and incidentals for artist and crew/band, advisor fee, taxes, insurance for third party liabilities and insurance for event cancellation due to artist non appearance and bad weather covering 100% of contractual value

Tender process rules

Following the receipt of the tender document, Manifestation of interest shall be submitted within the 13th of April 2025 by e mail to Franco Mulas (franco.mulas@marriott.com) and Paolo Lazzari (paolo.lazzari@marriott.com)

The non binding offer shall mandatory, at least, include:

- ✓ The quotation for the realization of the Gala night project on a turn key basis including:
 - The quotation for the Gala Night
 - parterre of artist for the gala night (*maximum ten artists proposals in the scope of work*)

Non Binding offer must be submitted:

- ✓ *Deadline:* The proposal must be submitted by the 4th of May 2025
- ✓ *PEC email:* The proposal shall be presented by PEC email to sardegnaresorts@postecert.it; copied **Mulas, Franco** (franco.mulas@marriott.com) and **Lazzari, Paolo** (paolo.lazzari@marriott.com)

Binding offer must be submitted:

- ✓ *Deadline:* The proposal shall be submitted by the 20th of May 2025

Offers will be evaluated on both sides (*technical and economic*) by Management, by using a scale of marks remeasured on the best offer, attributing 60% weight on the technical offer and 40% weight on the economic proposal
